

DIRECTIONS

FROM WASHINGTON, DC (via Rt. 95 South):

Take the Fredericksburg exit for Rt. 17 South. Take Rt. 17 approximately 40 miles to Rt. 635. Turn right onto Rt. 635, go about 3 miles to Rt. 637. Turn right onto Rt. 637 and go 1 mile to Spindles Millpond Rd. (dirt road) and turn left. Field site is on the left approximately ¼ mile down the road.

FROM MARYLAND (via Rt. 301 South)

Take Rt. 301 over the Harry W. Nice Bridge and continue about 15 miles to Port Royal. Turn left on Rt. 17 and go about 15 miles to Rt. 635. Turn right onto Rt. 635, go about 3 miles to Rt. 637. Turn right onto Rt. 637 and go 1 mile to Spindles Millpond Rd. (dirt road) and turn left. Field site is on the left approximately ¼ mile down the road.

FROM RICHMOND (via Rt. 95 North)

Take the Mechanicsville/Tappahannock exit (Rt. 360 East). Follow Rt. 360 about 50 miles to Tappahannock, then turn north on Rt. 17. Go about 14 miles to Rt. 637. Turn left on Rt. 637, go approximately five miles through Hustle to Spindles Millpond Rd. (dirt road) and turn left. Field site is on the left approximately ¼ mile down the road.

FROM VIRGINIA BEACH (via Rt. 17 North)

Take Rt. 17 to Tappahannock. Continue on Rt. 17 about 14 miles to Rt. 637. Turn left on Rt. 637, go approximately five miles through Hustle to Spindles Millpond Rd. (dirt road) and turn left. Field site is on the left approximately ¼ mile down the road.
